## A Message About the Rider Insurance Program from Ralph Libby at Megson Fitzpatrick

The insurance program has been providing protection for over 20 years!

The program has been set up and administered by the Federation to protect the property of foster parents, should damage occur due to the actions of a foster child. The policy will protect you to a maximum of \$500,000.00. We are actively pursuing increasing the limit to \$750,000 to provide a greater level of comfort to Foster Parents in the event of a total loss.

The important factor is that you must carry primary insurance in order for this rider to be activated. Your policy becomes the basis of the coverage provided by the Rider. If you have theft coverage on your primary policy, then you have theft coverage on the rider, and so on.

The deductible on this policy is the same as the deductible on your existing home or tenants policy, subject to a minimum of \$500.00.

Be sure to inform your insurance broker that you are fostering, as the insurance company needs to know this information. Have your broker put a note on your file and have them check with the insurance company to ensure that there are no restric-

#### **GET IT IN WRITING!**



When agreements are made for the coverage of excess costs related to your role as a Caregiver (ie. agreement for extra respite coverage due to your needs, or payment for special travel related to the child), get it in

writing from MCFD prior to incurring the expense, so that the original intent of the agreement cannot be misconstrued or forgotten leaving you out of pocket for the expense.

## 2010-2011 Year End Regional Delegate Reports

#### Vancouver Coastal Report by Peter Dueck

Protocol reviews continue to confound, confuse and frustrate foster parents. Many parents are hopeful that one of the important outcomes of the Residential Review effort will be a more just and respectful review process for complaints about fostering.

Fostering is becoming more challenging; it seems obvious that the needs of foster children are more complex and more prevalent. This raises issues such as reassessing levels of care, respite, training and support and remuneration.

Over the year there has been considerable talk about foster parents becoming more skilled and professional in light of the changing profile of children in care.

40% of all adoptions in BC are by foster parents. This is a most impressive development. Post-adoption support, however, is frequently inadequate and short-sighted. The support program needs to be reviewed.

Foster parents know their children best and must be their best, informed and skilled advocates. Let's remember the insightful words of Imanuel Kant, "Science is organized knowledge, wisdom is organized life".

By year end we are almost accustomed to the boundary changes in the region. Folks are neutral or somewhat positive to this administrative adjustment.

Other developments from 2010-2011:

Residential Review Project: a 5 year plan to improve the care of children and youth in care. This review is conducted jointly by MCFD and FCSS. This is likely the most promising and vested project in memory. Many foster parents and others are optimistic that fundamental and meaningful changes for the good of children in care are in the offing.

4th International Conference on FASD: The conference brings together the "who's who" of FASD and invites caregivers and others to catch up on the very latest in science and practice related to FASD. Two salient findings are: FASD is even more prevalent than projected and there is encouraging new science and resulting practice relative to prevention and amelioration.

#### Fraser Report by Russell Pohl

Some of the issues that are happening in the region are seemingly on going:

- Receiving level one relief is still a big issue. Foster parents are becoming more agitated.
- > A seemingly unfair leveling system specific to certain offices within the region.
- Ongoing protocols; not enough support and peer support for those in need.

Our region is faced with many challenges:

- > Attendance of new and seasoned foster parents in further training and work shops is low.
- ➤ Fraser Valley Foster Parent Association is available to provide, workshops or education to foster parents. Social workers in our region should be providing referrals to our program.

Some of the successes in our region are:

- We have continuous ongoing monthly meetings in two locations in Surrey and Langley.
- Workshops are being well accessed and attended by the longterm foster parents and some newer foster parents. Our "Change for Change" fundraiser is ongoing and doing well.

As a board member on the BCFFPA I had the opportunity to go to PEI as our representative to the CFFA board. I learned a lot and realized that, comparatively, our province's foster services are among the best in the country. I have sat in many recent meetings for Residential Review and am excited and hopeful for the coming changes in BC.

#### Northern Regional Report by Sherrie Jones

Another Year has come and gone, and it is now time to reflect on all that has occurred during this time.

This year has been a year full of trials for foster parents as they try to keep informed with the ongoing changes in how MCFD is now doing business.

Dawson Creek was to be the area for the North to pilot the CAPP program. There have been training sessions in this region, unfortunately foster parents have not been included in this training. With the changes within MCFD there has been confusion around what this program will look like and how it will be delivered.

The issue of interpreting policy differently from office to office is a ongoing issue. There is confusion at times for foster parents and support workers when each MCFD office works with policy in a different manner. This includes contracts, placements, protocols, following time frames, foster parent expectations, etc. I once again feel that many of the ongoing issues arise from communication or lack of communication. The problem of getting information distributed to all areas of the North and North West is a ongoing issue.

Being the Provincial Rep for such a large area, the issue of being able to gather information and have knowledge of what is happening in our region, is a ongoing problem. Without information, the BCFFPA is unable to assist or speak for all foster parents. I encourage every foster parent, Local or Regional Association to contact myself or the BCFFPA Office when in need of information or support. We need to stand together and support each other when issues and concerns arise.

There are team building meetings happening in some areas between MCFD and foster parents. It is hoped that these

meetings will help deal with issues and concerns and encourage a good working relationship between all.

Axis continues to provide Support Services to foster parents within the North Region. They supply support and training events for foster parents and also assist MCFD with foster parent training. With the lack of funding to host training events for foster parents the training that is provided by Axis is very valuable.

I attended the focus group in Vancouver on Residential Redesign. There was a wide range of service providers at this meeting, and the work and ideas presented during this session was incredible. As work progresses on this project it will be interesting to follow what plans are put in place and what the new look will be for providing care to the children and youth of our Province.

With the ongoing changes within MCFD and how services are going to be delivered, the next year is going to be a trial for both foster parents and Ministry staff. I encourage open all to communicate openly and hope that all parties involved will be included in training so they are informed on how business is going to be done.

In closing I would like to Thank each and Everyone of you for opening your heart and your home and caring for our children and youth that are going through a difficult time in their lives. The energy put into giving these individuals everything they need to have the best possible outcome in their life is the reason that we all Foster.

#### Vancouver Island Report by Jo Axe

As a new board member, I have been busy learning about BCFFPA and its mandate to represent and support foster parents in providing quality care in British Columbia. The board meets monthly, usually via conference call, to discuss concerns brought forward by foster parents and other issues related to foster parent support. During these meetings, we brainstorm potential solutions and talk about current matters with our MCFD liaison and occasionally with other MCFD representatives.

This year there have been some lows and some highs. Sadly, we have lost three long-time foster parents on the Island; **Marie Davidson** — she fostered for over forty years, touching many hearts with her generosity; **Louise Dol** — a longtime BCFFPA board member who was a tremendous advocate for foster families and a passionate supporter of foster parent rights; **Linda McLaren**, who fostered for many years in the Port Alberni area.

We have also seen some foster parents retire after many years caring for children, and new foster parents beginning their own journeys. Our gratitude is extended to all foster parents, past and present, who have contributed to the well-being of BC's children.

One issue that has been brought forward this year by local foster parents on the Island is the inconsistent implementation of Ministry policies, which can result in confusion and uncertainty for foster parents. In addition, there has been concern expressed about the difficulty in retention of foster parents – perhaps you could help us understand how we can further support parents so that they continue in their important roles. As we work towards resolution of these matters, we welcome your insights and comments.

#### Interior Report by Kevin Daniel

This year has been a very active and productive year for the Interior region as we head into our yearly AGM. In the Kamloops area they recently finished a pilot program that involved third year social work student who attend Thompson Rivers University. The students worked with the foster parents to further their own skills and understanding of what happens in the foster home and the responsibilities of a foster parent in the community. We look forward to hearing the report that will be presented at the IFCO Conference in July.

IFCO has been one of the leading focuses in the Interior region over the last year as our area Locals worked on fundraising for a "Once in a Lifetime Event.". Once it is signed it is difficult to have it changed, and you may find yourself out of pocket.

# **Home Closures and Contract Changes: Become a Self-Advocate**

It appears that instances of home closures and contract changes are on the rise throughout some regions of BC. Please be aware that if you are in need of support you have the right to request that another foster parent or support worker attend meetings with you. If you are experiencing something that appears to be against common policy and practice, please contact your BCFFPA regional delegate or the BCFFPA provincial office so that we can document the circumstances and support you.

Our mandate is to advocate for, support and inform foster parents. We are in continuous contact with the Ministry provincial office and have the ability to address regional and provincial issues directly with the Minister and her representatives. Please advocate for yourself and your family at all times by staying in touch with us when you experience difficulties with placements or relationships with MCFD workers. While we can't agree with our coworkers at all times, our foster parents should always be treated as respected partners in the care team.

# IFCO 2011—Victoria, BC

The 5 days of IFCO were a huge success and the credit goes to Margaret Howley and the planning committee and Sandy Case and all of her volunteers. The facility was excellent and the workshops, plenary and keynote speakers were fantastic and covered everything from brain development to foster parent recruiting and everything in between.

At the opening ceremonies the flags of the 27 nations attending were brought in. As usual there were dignitaries who spoke including the Lt. Governor, Steven L. Point. Victoria's Mayor's representative spoke to welcome us and touched my heart when he spoke of his cousin who fostered on the Island for 40 years and recently passed away. He understood the fostering mindset.

The BCFFPA had a display booth and we gave away an abundance of information as well as apples donated by the Okanagan Fruit Association. This was a big draw and Jayne and I had a chance to talk to people about fostering in BC and to share some of things BCFFPA has accomplished over the past 44 years. Many policy makers and foster parents were very interested in our work with the Ministry to create BC's Foster Parent Rights document.

My personal highlight of the week was an invitation from the Japanese delegation to meet with BC foster parents informally in order to compare fostering details between two different nations. We could have spoken all night. Most important to note is that foster parents are the same all over—our kids are important and we are all working to give them the best start in life possible though we work in vastly differing systems. In Japan there is a population of 1.4 billion! 40,000 young people are in care however only 3,500 are in foster care placements—the rest are in institutions. When a child is surrendered at birth they go to a children's home for the first 2 years of life before they are available for adoption or foster care. After speaking to the delegation it reaffirmed that, though we may not have everything we want for our kids in care, in other areas of the world it is not as easy.

Many of our BC foster parent members chose to become associate members of The Anne Funds Project. This project is to support foster parents and children in Japan who are transitioning to adulthood. In Japan all foster children are emancipated at 18 but do not reach age of majority until they are 21. It becomes very difficult for them to establish themselves.

I look forward to the next IFCO Conference and am anticipating the location announcement!
