## Message from MCFD Deputy Minister, Dr. Stephen Brown



The BC Federation of Foster Parent Associations (BCFFPA) is a longstanding and deeply valued partner of the Ministry of Children and Family Development. While I have been fortunate, over the past few months, to meet with Heather, Jayne and a number of foster parents, I welcome this opportunity to introduce myself to all of you – and to offer my sincere thanks for the care and support you offer vulnerable children and youth when they need it the most.

I've been asked how it is I came to be deputy minister at MCFD. I started my career many years ago as a youth worker in London, England and after immigrating to Canada, worked for non-profit child and youth organizations in Alberta, all the while continuing my education. From there, I headed up the province's Capital Regional

Child and Family Services Authority, eventually leading Alberta's *Child Welfare Act* review.

# Protect Your Home! Tips to Lessen the Impact of Old Man Winter

With winter here in British Columbia it is never too late to think about making your house safer from anything that winter can throw at it. Hopefully these tips will help you lessen the chance of anything happening and assist you in the event you do have a problem.

#### **Ruptured Pipes**

Undetected ruptured water pipes can cause devastating amounts of damage. When ruptured pipes thaw, escaped water can accumulate in pools eventually leading to collapsed ceilings and flooding to the floors below. Damage to structural features and electrical wiring often pose a threat to the safety and well being of a building's occupants.

Take the following practical steps to reduce the likelihood of frozen water pipes.

- Seal off areas where cold air can enter the building (especially if there are pipes nearby) and insulate attic spaces, outside-facing walls, and the sides of water tanks.
- Insulate water pipes or use electric trace heating elements and protect pipes in unheated areas like attics, basements, outbuildings, and under floors.
- Open attic trap-doors on cold winter days to allow heat to circulate upward.
- Leave central heating on a 'frost protect' setting overnight.
- Re-washer any dripping taps to reduce the likelihood of freezing.
- Ensure that the building's 'stop tap' can be accessed quickly in an emergency.

If you discover a frozen or ruptured water pipe:

- Turn off the water at the building's main 'stop tap' immediately, and turn on the faucet closest to the rupture to allow water to flow through.
- If any water has leaked near electrical wiring or appliances, immediately shut off electricity at the main panel and consult an electrician. Never touch wiring or equipment that has become wet.
- Immediately contact a professional plumber to make necessary repairs. Never attempt to thaw pipes with a blowtorch or heat gun.
- Ensure that no building occupants are present in areas that may have become unsafe due to water-leakage.
- If an adjacent area is safe to enter, remove any contents or furnishings that could potentially be damaged as the pipe thaws
- Inform your insurance company of any sustained or possible loss.

#### **Blocked Drains and Gutters**

A rapid thaw can melt masses of accumulated ice and snow, overwhelming drains and gutters, and ultimately flood buildings.

At least twice a year, ensure that gutters and drains are clear of any debris that might block the flow of water away from a building.

- After gutters and drainpipes are clear of obstructions, the gutters should be flushed out with a hose. All drainpipes should be positioned to drain water away from the building's foundation.
- Following periods of heavy snowfall, it is advisable to have a
  contractor or custodian clear snow and ice from any flat roof
  surfaces. Snow accumulation can cause a flat roof to buckle,
  and falling ice and snow can injure people or property below.
  Snow should be cleared from roofs in a safe and controlled
  manner, ensuring that the areas below are free of vehicles
  and passers-by.

Winter weather poses many challenges The benefits of regular maintenance include decreased risk of accidents, lower costs and increased security.

Each position has a two-year term. Nominations for each position **must** be received by the BCFFPA Provincial office by March 26<sup>th</sup>, 2012, for distribution to the membership.

The bylaws regarding eligibility to become an Officer of the Federation, state the following:

- Paid in full member as of January 31<sup>st</sup> of current year.
- Must be present at the AGM unless excused by the Board for extraordinary reasons.
- Nominations from the floor will not be accepted.
- Candidates for these officer positions shall be selected by the Nominating Committee from a pool of foster parents and associate members. They will be chosen for their knowledge and expertise in relation to these positions.
- The successful candidates will be elected through a combination of mail-in votes and the votes of those attending the Annual General Meeting.
- Associate Members, elected to hold positions on the Federation Board of Directors, shall have full voting privileges during their term of office.
- Any candidate for these positions, must have held a BCFFPA membership in good standing for at least three years immediately previous to running, and must have served for at least one year in the previous three years on a local or macro regional council, or on the BCFFPA Board of Directors.
- Nominations require a nomination form duly moved and seconded by two members in good standing (ie. current membership as of January 31<sup>st</sup> of the present year).

# Fetal Alcohol Spectrum Disorder (FASD)

submitted by MCFD

FASD is the umbrella term that describes the range of effects that can occur in an individual whose mother consumed alcohol during pregnancy. FASD is often not visible and can include lifelong challenges with learning, memory, attention, problem solving, behaviour, vision and hearing. A person with FASD may not understand social situations and their behaviour is often interpreted as problematic, rather than a symptom of an underlying condition.

It is not known how much alcohol is safe to drink during pregnancy. Therefore, it is safest not to drink at all when pregnant or planning a pregnancy. For more information on prevention of FASD, please visit <a href="www.bestchance.gov.bc.ca">www.bestchance.gov.bc.ca</a>.

Many children who enter into the foster care system could be affected by FASD. It is important for children and youth to be assessed if it is suspected they have FASD. The assessment can help families and service providers better understand a young person's strengths, challenges, and the strategies that can help them succeed.

Diagnostic and assessment services are available through each Health Authority through the Complex Developmental Behavioural Conditions (CDBC) network. Talk with your social worker if you suspect a child in your care may be affected by prenatal alcohol exposure.

Foster parents can access FASD Key Worker and Parent Support programs, funded by the Ministry of Children and Family Development. Key workers assist families in understanding FASD by providing education and information specific to the needs of the child and family. They are familiar with community resources, and assist families in accessing support, health and education services. Parent support includes local parent and grandparent FASD training, parent mentoring and parent support groups. Parents, grandparents and caregivers can self-refer to the program. A confirmed diagnosis is not required to access services. Children with FASD do best when their individual strengths are recognized and built upon in a supportive environment adapted to meet their needs. A learning module on FASD is included within the current BC Foster Parent Education Program and will be updated as part of the Caregiver Education Framework project. It will include best practice knowledge to support caregivers in understanding FASD and how best to respond to the strengths, needs, and challenges of the children and youth they care for. The FASD Key Worker and Parent Support Program staff will be

included in the development of the revised FASD learning module

and linked into future delivery of the training in a variety of ways

to integrate the learning into everyday living situations.

The Ministry of Education funds the Provincial Outreach Program for Fetal Alcohol Spectrum Disorder which supports teachers of students with FASD by explaining the educational implications of the disability. This program shares current FASD research, resources and successful practices and provides a network for teachers. # BCFFPA's AGM follows Roberts Rules of Order. Who is Robert and why do we follow his rules?

Henry Martyn Robert was an engineering officer in the Army. Without warning he was asked to preside over a public meeting being held in a church in his community. He quickly realized that he did not know how. Though he tried anyway, he was ultimately embarrassed by the outcome. This event, which may seem familiar to many of us, left him determined never to attend another meeting until he knew something of parliamentary law.

Mr. Robert discovered and studied the few books then available on the subject. From time to time, due to his military duties, he was transferred to various parts of the United States, where he found virtual parliamentary anarchy, since each member from a different part of the country had differing ideas of correct meeting procedure. To bring order out of chaos, he decided to write **Robert's Rules of Order**, as it came to be called. The first edition was published in 1876.

Robert's Rules of Order provides for constructive and democratic meetings, to help, not hinder, the business of the assembly. The Rules provide common guidelines and procedures for deliberation

and debate in order to place the whole membership on the same footing and speaking the same language. The conduct of ALL business is controlled by the general will of the whole membership. The Rules set out and support the right of the deliberate majority to decide and ultimately, to act according to its considered judgment AFTER a full and fair "working through" of the issues involved.

"Special Resolutions": At this time of year, prior to the BCFFPA's Annual General Meeting, we receive proposals for special resolutions. A special resolution is a proposed change to our governance model or common practice that is presented to our membership as a whole and voted on. We require a majority vote for the special resolution to be passed. When a special resolution is adopted into the Association's practice or articles, the wording of the resolution is then submitted to the governmental authorities to become part of the Association's permanent documentation.

When agreements are made for the coverage of excess costs related to your role as a Caregiver (ie. agreement for extra respite coverage due to your needs, or payment for special travel related to the child), get it in

writing from MCFD prior to incurring the expense, so that the original intent of the agreement cannot be misconstrued or forgotten leaving you out of pocket for the expense.

# Home Closures and Contract Changes: Become a Self-Advocate

It appears that instances of home closures and contract changes are on the rise throughout some regions of BC. Please be aware that if you are in need of support you have the right to request that another foster parent or support worker attend meetings with you. If you are experiencing something that appears to be against common policy and practice, please contact your BCFFPA regional delegate or the BCFFPA provincial office so that we can document the circumstances and support you.

Our mandate is to advocate for, support and inform foster parents. We are in continuous contact with the Ministry provincial office and have the ability to address regional and provincial issues directly with the Minister and her representatives. Please advocate for yourself and your family at all times by staying in touch with us when you experience difficulties with placements or relationships with MCFD workers. While we can't agree with our coworkers at all times, our foster parents should always be treated as respected partners in the care team.

## It's That Time Again! Submit Your Application for these BCFFPA Bursaries

#### Maurice Graydon Bursaries (4)

Maurice Graydon, a local Maple Ridge author and retired businessman, generously provides annual donations for these scholarships. The Maurice Graydon Bursaries will be awarded to youth currently or formerly in care who wish to continue their education.

Application Criteria: The successful incumbents will provide proof of registration with a business or vocational institution and demonstrate financial need. Bursaries will be awarded to those who demonstrate the highest marks.

Second Application Deadline: May 31st, 2012\* (Previous deadline was January15th, 2012)

#### William Curtis Memorial Fund

The William Curtis Memorial Fund was established in January 1979 for foster children who have reached the age of majority and wish to continue with their education. It is awarded annually.

Application Criteria: Former foster children residing in BC, aged 19 who show an interest in continuing their education (whether to complete high school, attend a business/vocational school, college or university). High marks, though considered, will not be the only determining factor in awarding this bursary.

Application Deadline: May 31st, 2012\*

### Merv Davis Bursary

The Merv Davis Bursary was established for foster children residing in the Coquitlam, Maple Ridge, Port Coquitlam, Port Moody or Pitt Meadows areas who have reached the age of 19 years old and wish to continue their education.

Application Criteria: Any youth who has been in care of the Ministry, residing in the Fraser River corridor (noted above), who has reached the age of 19 years, who intends to further his/her education, whether to finish high school, attend business or vocational school, college or university, and where other funds available are inadequate, is eligible to apply. The highest marks, although considered, will not be the only determining factor in the allocation of the bursary.

Application Deadline: May 31st, 2012\*

## **Natural Child Bursary**

The Natural Child Bursary was founded in 1991 and is intended to be accessed by children born or adopted into a family providing foster care in BC.

Application Criteria: The eligible youth must be the child by birth or adoption, as stated above, to a foster family who are members of BCFFPA for three consecutive years since 1990. This can also apply to the child of an individual who is an Honorary Life Member. The youth must reside in BC, have graduated from highschool and is interested in extending his/her education in any field of study. High grades, though considered, will not be the only determining factor in the allocation of bursary funds.

Application Deadline: May 31, 2012\*

# A Message to Foster Parents from BC'S Representative for Children and Youth —Mary Ellen Turpel-Lafond

Happy New Year, everyone. I hope you had a chance over the holidays to enjoy family and friends, and to make special memories with your foster children. I always remind myself at the start of a new year how very fortunate we are to have people like you who willingly step forward to offer safe and secure homes to children in need. Thank you for being there as a vital part of our child and youth serving system.

I'd like to share with you a few items that kept us very busy in my Office this Fall. On top of the investigative, monitoring and advocacy work that we do, we also held a youth Summit, released an It Gets Better video and presented Awards of Excellence to some truly outstanding individuals and organizations who, like you, are committed to children and youth in this province.

Our Summit in October this year focused on the experiences of B.C.'s immigrant and refugee youth. Much like many children in care, these youth face a list of challenges every day, and I was interested in hearing their perspectives. *Fresh Voices from Long Journeys: Insights of Immigrant and Refugee Youth* brought together more than 120 immigrant and refugee youth from more than 30 countries. They brought with them a wealth of experience depending on their backgrounds, their entry points to Canada and their legal status here. Participants ranged from those who came with their families, speaking fluent English, to those who had only recently arrived and were still awaiting word on their claims for refugee status.

These young people shared their stories, ideas and recommendations with about 60 invited adult guests – B.C. business people, political leaders and policy makers who had the capacity not just to listen, but also to respond to the issues raised. A dedicated and inspiring 23-member Youth Advisory Team made up of immigrant and refugee youth from the Lower Mainland was instrumental in planning the conference.

We are now working to ensure that the voices of these B.C. young people are heard more clearly by decision makers as we join with these youth to build a better British Columbia.

Also in October we announced the winners of the fourth annual Awards of Excellence, given to those who are doing exceptional work that is changing the futures of the children and youth they come in contact with every day. Two outstanding youth, a police officer who mentors youth, and a number of remarkable organizations were recognized for their excellent work on behalf of B.C.'s vulnerable children and youth. This year's winners include:

Youth Leadership (co-winners): Samantha Claver and Lilia Zaharieva, Victoria

Service Provider: Mary Manning Centre, Victoria

Cultural Heritage and Diversity: Aboriginal Infant Development Programs of B.C.

Advocacy: Dawn Johnson, Ministry of Children and Family Development. Vancouver

Innovative Services Award: Burnaby Board of Education and Ministry of Children and Family Development

Mentoring Award: Constable Richard Lavallee, Vancouver

Lifetime Achievement Award: Tracy Porteous, Vancouver, for her longstanding work in domestic violence.

In November, to recognize National Child Day, my Office released a video in support of the It Gets Better project aimed at inspiring B.C. lesbian, gay, bisexual and transgender (LGBT) youth to focus on a positive future. The It Gets Better campaign was launched in the U.S. in 2010 in response to several teen suicides by LGBT youth. Thousands of videos have been submitted by politicians, celebrities, organizations, activists and youth from around the world. Campaign supporters emphasize that every video can change a life. The videos also encourage young people to seek help if they are in crisis. Bullying and homophobia can deeply hurt those who need our support, and can destroy families, communities and lives. We have a responsibility to ensure all young people are encouraged to thrive, because they all have the right to be respected and supported.

The video from my Office highlights the experiences of a variety of British Columbians in dealing with bullying, homophobia, discrimination and being different. Video participants include Dr. Hedy Fry (MP for Vancouver Centre), Spencer Chandra Herbert (MLA for Vancouver West-End), several youth activists, a female Victoria police officer, a First Nations youth worker, a young Victoria opera singer, cast and crew from the current Vancouver production of Mamma Mia, and others. ## Exciting cross-Canada adventure for BC Youth

Envision a life and job skill-building program that takes a group of youth on the adventure of a lifetime—travelling across Canada to work on organic farms in Manitoba, then back to BC for parks and recreation job experience, all the while incorporating French language and cultural learning opportunities.

Now envision this program is an all-expenses paid adventure for youth in care and former youth in care.

This was the reality for five BC youth, thanks to a partnership between the Ministry of Social Development, the Intergovernmental Relations Secretariat, the Ministry of Children and Family Development and the program itself—Katimavik.

Katimavik provides learning through volunteer service programs for youth between the ages of 17 and 21. The programs incorporate second-language and cultural-heritage learning opportunities, interpersonal skill development, self-esteem building and job-skill building programs to help young people enter the workforce with confidence.

## Katimavik



This year, for the first time in BC, all five participants were youth in government care and former youth in care. According to the youth, it was a "huge success" where they learned everything from the importance of living a healthy lifestyle through nutrition and exercise, to environmental stewardship to valuable employment and leadership skills.

Six months in duration, the Katimavik program wrapped up in December. The camp started with a two-month stay in Winnipeg, where participants volunteered on small community organic farms, learning about local food production and sustainable farming practices. Following that, participants spent four months in Fort Langley volunteering at various office jobs, including parks and recreation and administrative jobs.

This special pilot project was funded through funds within the existing fiscal plan.

#### Quick Facts:

"Katimavik" means "meeting place" and is a federally funded program that has helped over 30,000 youth since its launch in 1977.

Five BC youth, between the ages of 17 to 20 were selected by MCFD to participate in this year's pilot project, to build on opportunities for serving under-represented and vulnerable youth.

As part of the program, participants were offered a chance to billet with a host family in the community for 10 days. This helps the youth in forging positive relationships with community members and getting a more in depth look at the lifestyle and culture of people living in the host region.


# Have You Hugged Your Social Worker Today?

# What's the Difference Between Support and Advocacy?

**Support**—[peer support] occurs when people provide knowledge, experience, emotional, social or practical help to each other. It commonly refers to an initiative consisting of individuals who are trained in offering appropriate support to others. It usually looks like *listening* or a *dialogue* with a theme of providing *guidance*. A "peer" is someone who has "been there, done that" and can relate to others who are now in a similar situation. Supporters can also be people who have a great deal of knowledge about a situation.

**Advocacy**—refers to a *political process* by an individual or group which aims to influence public policy, practice and decisions within a system (political, economic, social or institutional). The form of advocacy can include a myriad of activities such as media, public speaking, commissioning, research, lobbying or direct contact with legislators or governing bodies.

BCFFPA provides *support* and *advocacy*. We offer support, similar to that provided by BC's regional agencies however we are also able to advocate directly with MCFD workers, managers and directors—even speaking with the Deputy Minister and the Minister herself a couple of times each year—regarding changes needed within MCFD policy and practice.

It is our role to report to MCFD the statistics, successes and challenges of service delivery within all of BC's regions. When foster parents speak with our Provincial office or one of our delegates, we log each concern, gathering numbers and information to bring forward to Ministry officials at the regional and provincial levels. Sometimes it takes a while to see measurable change, but this is the way BCFFPA ensures positive shifts are taking place to provide better services for foster parents and the children in their care.
