BC Foster Parents Association (BCFPA) is a provincial organization for foster parents, run by foster parents. We are a registered non-profit charity which aims to bring together foster parents, social workers and other stakeholders who are working to continuously improve the standard of care for children and youth in our province.

We provide information to the general public about fostering and recruitment services to the Ministry of Children and Family Development and Indigenous Child and Family Service Agencies. We offer our community a support network through our local Branch affiliations and our Solutions Program, accessible fostering information and education, a hub to share news across our sector and insurance resources for foster caregivers. For over 50 years, we have consulted about the revision and development of policy and practice within BC's child welfare sector.

BCFPA's structure facilitates contact with all foster parents in the province. We provide funding to our Branches and Regional Councils, and we maintain a Board of Directors that represents the diversity of our province. BCFPA's Board of Directors provincially, regionally and at a community level are all volunteers, elected by their foster parent membership community.

Notes from the Office

Happy Foster Family Month to all of our friends and community members! Our AGM takes place at the beginning of Foster Family Month this year. It also coincides with the interregnum period as we wait for a new provincial government. Due to the timing, we won't have a Minister of Children and Family Development to present at our AGM but we are happy, as always, to welcome Dr. Jennifer Charlesworth, BC's Representative for Children and Youth, to open our conference day.

At the AGM we'll be announcing our next President of BC Foster Parents Association. New leadership is always an exciting time. Though we continue to follow our strategic priorities for advocacy and agency service, a new president always has something new to add to the mix. At the end of AGM 2024, we'll also be saying a sad farewell to both Kevin Daniel and Raquel Lesieur. Kevin has been serving our community for the majority of the past 14 years! Raquel joined the board in 2019 and has been diligently serving the Interior region these past 5 years. We will miss them both and wish them the very best in their future endeavors.

Since June, we've been focusing on our advocacy efforts and have met with the Minister of Children and Family Development, the Provincial Director of Child Welfare, the Executive Director of Guardianship and Adoption, and the Assistant Deputy Minister of Service Delivery. All have been receptive to the fostering community priorities we highlighted, asked pertinent questions, and have indicated that they will support our efforts to ensure troublesome trends and areas that require development are addressed. The bulk of our work takes place behind the scenes and includes conversations with local ministry offices to better understand their process, noting office staffing concerns that regularly impact practice, and to make connections with leadership teams to engage in some challenging conversations. Our current priorities include addressing practice variations and policy interpretations that can fluctuate depending on the region.



for quite some time, but we're happy to report that the work is underway again. There will be a review phase for the project coming up soon, and we plan to have the final product out by the end of the year. We are offering another in-person workshop series from Fall 2024 through Winter 2025 in Victoria, Richmond, Langley, Kamloops, Kelowna, and Prince George (page 13). We are offering 2 additional locations to reach a broader audience. Childcare and mileage reimbursement allowances will be increased but we won't be providing lodging for out-of-town attendees this year.

BCFPA members should have received a call in the past year from a board member, about participating in our regional Zoom calls that take place a few times each year. It's an opportunity for our members to connect with our Board of Directors and others in their region, and let us know what their challenges are, what's working well in their community, where they'd like to see some change, and if they'd like to be involved as a board member when there are opportunities. Provincial Strategy Initiative

Fostering is complicated. From the work that caregivers like you do to meet the needs of children and youth in your home every day, to the work that local resource teams do to support your practice, to the work that MCFD does at a provincial level to address arising issues and to improve outcomes for children and youth across BC. With so many layers to work with and so many different factors coming into play, it can be difficult to determine what problems are most pressing, and what areas of improvement will benefit our sector the most. While our Solutions Program team works to support the individual concerns of foster caregivers, BCFPA recognizes that a broader lens is necessary to really create change and get ahead of issues that face foster caregivers.

For this reason, BCFPA has introduced a provincial strategy initiative, headed by Amanda Oliver. Through this program, we have been working to research, identify, and collaborate with MCFD at all levels to address the complex, broad-scale issues impacting foster caregivers and the children and youth they care for.

We would like to introduce you to the first set of advocacy objectives that we have identified and recently presented at meetings with the Minister of Children and Family Development, the Honourable Grace Lore, and her team.

Assessment of the impact of a perceived increase in the number of Foster Care Home Investigations and Quality of Care Reviews across the Province.

Foster caregivers have been making our team aware of a perceived increase in the number of investigations and reviews taking place across the province. The impacts of these investigations can be devastating for caregivers, particularly in the case of false allegations. While we work to obtain more definitive numbers, BCFPA's advocacy team is meeting with MCFD around the province to get their views on this alarming perception.

Initial impressions suggest that there is not necessarily a statistical increase in instances of review or investigation across the province, but their impact on foster caregivers and their role as a focal point of stress for our community remain important issues to address. As our team continues to dig into the issue and to collaborate with MCFD at all levels to address it, we hope to begin alleviating this stress.

Presently, some of our recommendations are for MCFD to emphasize the importance of proportionate responses to allegations and to ensure that actions taken are done with consideration and respect for the dignity and reputation of foster caregivers, and to ensure that caregivers undergoing these processes are made properly aware of the support services at their disposal.

At our meetings, we have been happy to see that this issue was received with due consideration and concern, and an understanding of how severe an impact these actions can have not just on individual caregivers, but on the sense of safety and security for our whole community.

Improvement of culture within the sector via developing positive working relationships between caregivers and MCFD/ICFSA staff.

Improving working relationships between social workers and foster caregivers is an issue as old as our sector itself. Lots of issues can crop up which impede communication, break trust, and otherwise strain the vital connection between caregivers and child welfare sector employees. Our research and experience clearly show that having a positive culture of collaboration and respect between caregivers and workers is essential to creating a sense of security and fulfillment for caregivers, and while this issue is no simple solve, we have determined a number of ways we believe that it can be improved.

Foremost as caregivers are put under greater strain and higher expectation than ever before, that

dedication needs to be recognized and respected. By emphasizing the skills and competencies required to provide quality care to children and youth, we hope to bolster trust between workers and caregivers and normalize it for caregivers to be viewed as peers, not just contractors or employees. Various options exist and have been presented for directly improving these relationships as well.

One particular issue that BCFPA wished to address was the usage of the term "stranger care" to describe foster placements, and "family care" to describe Out of Care placements. We were glad to be assured by leaders at MCFD provincial office that they don't support the use of the term "stranger care".

Enhancing training opportunities and onboarding practices for new foster caregivers.

With the needs of children and youth in care rising, it's important for foster caregivers new and old to have their training and preparedness for these often complex needs bolstered as well. In particular, there have been a significant number of complaints from both caregivers and social workers that the PRIDE training model is outdated and in need of updating. Our program is focusing on advocating for vital improvements to this and other avenues of learning so that caregivers feel confident in meeting the needs of our province's children and youth.

Consistency is key as well, and currently, a lot of variation exists between regions with respect to how caregivers are trained and what opportunities are made available to them, though our regional support agency partners are always diligently at work to increase the options available to foster caregivers. BCFPA is also always looking for new and valuable workshop options to provide.

One valuable resource that has recently been made available through our partners is the Provincial Support Agency Caregiver Learning Network (or "PSACLN") which now enables easier access to online learning materials and even in-person events for members of our community throughout BC. We'd like to acknowledge the excellent work that our partners have done in putting this together, and if you haven't already, we strongly encourage you to take advantage of the opportunity this network presents. Find out more at psacln.ca.

Focusing on the vital importance of retaining skilled and experienced caregivers.

It's not just important to ensure that we are recruiting more foster caregivers, but that we are retaining and valuing those we are already fortunate to have serving our children and youth. A lack of foster placement options can lead to higher reliance on contracted group homes-particularly for youth. As most know, these are not always the best fit for youth, and making foster placements available is indispensably important to promote the best possible outcomes for young people in our system of care.

We know that creating a strong sense of community is one vital part of this process, and BCFPA, as well as MCFD and the various Indigenous Child and Family Service Agencies in BC are always looking for ways to help get foster caregivers more connected with each other. Fostering is a difficult calling as it is, and doing so in isolation makes it that much harder. We will always continue seeking ways to bring our community together as we move into the future.

BCFPA is currently looking into administering exit interviews for all caregivers leaving the system, in order to determine what trends and root causes may exist and be impacting retention rates. We want to know why caregivers choose to leave the system, and moreover, what our advocacy initiative can do to make fostering a more practical, sustainable lifestyle for everyone. If you or someone you know have stopped fostering, or are seriously considering leaving the fostering system, we would welcome a discussion about your experiences and reasons for doing so.

Lastly, we would like to say that we were very grateful to see that Minister Lore and her team are very receptive to the issues listed, and we feel confident that we will find great success in the process of working in partnership to address them. With this new initiative, BCFPA hopes to help improve working conditions for foster caregivers, and to promote a spirit of cooperation and collaboration throughout all levels of the sector.

FOSTERING EARLY DEVELOPMENT (FED) PROGRAM

The Fostering Early Development (FED) Program is an MCFD-funded program (running out of a non-profit in Vancouver) that provides developmental screening and support to all children in care, from birth to age 6, along with ongoing education and training for foster caregivers. This program has been instrumental in detecting delays in development early, providing necessary referrals for early intervention support services, advocating for further diagnostic assessment when needed, and supporting foster caregivers as they care for vulnerable children.

BEAMING BRIGHT, YOU'RE A SHINING LIGHT

Beaming Bright, You're a Shining Light is an early social and emotional skills development program for babies and young children aged 0 to 6. Developed by an experienced parent educator, Lynne Cox, in partnership with a kindergarten school teacher, this program is created with a wealth of valuable knowledge and testimonials of real results. Lynne herself, speaks to how building the program has even positively impacted her as a mother and grandmother.

With a collection of free-to-use resources available online, this program can be implemented at home from birth by parents and caregivers, as well as in daycares and classrooms up to and beyond the age of 6. Each lesson is taught through fun age-appropriate activities that aid in the development of other early childhood skills. Resources include storybooks, audiobooks, music, lesson plans and materials, as well as an in-depth look at the program in action.



SECTOR NEWS & UPDATES



British Columbia to take new direction in supporting children, youth, and families.

Note: The linked Don't Look Away report covers heavy topics surrounding grief and loss, and abuse. Please proceed with care.

In response to the Don't Look Away investigation and systemic review (bit.ly/4efHyNo) released by the Representative for Children and Youth (RCY) on July 16th of this year, the provincial government forms a new approach to child, youth, and family welfare. The review, which calls for a more collaborative system to support the well-being of BC's families, covers the following four major themes:

- the prevention of intimate partner and family violence;
- enhanced family support services;
- improved inter-agency collaboration;
- and improved support for those providing kinship care.

To take action on building this new approach to child, youth, and family welfare, the government will form a group of senior public officials across Canada. The sole purpose of this group will be to strategize and guide this new direction. This process is expected to take place throughout Autumn. The focus of their work will cover the following:

- developing a child and youth action plan that focuses on child and youth well-being;
- developing an outcomes-based framework to ensure that actions taken are working to improve the lives of our most vulnerable children, youth, and families;
- strengthening information sharing between ministries and service providers so that when children and youth are struggling, they are connected with the supports they need;

- requiring that government policy decisions consider the implications for children and youth;
- working across ministries to address the causes and ongoing impacts of family and gender-based violence, especially for Indigenous women, girls, Two-Spirit people and children;
- examining what functions of family supports and child protection can be separated to provide a more coordinated approach focusing on the wellbeing of children with their families;
- exploring the reconfiguration of child and family services across ministries including for Children and Youth with Support Needs and Child and Youth Mental Health;
- and exploring the establishment of a body for the purpose of supporting Indigenous governing bodies with the resumption of jurisdiction.

The Province commits to moving forward together with First Nations and Indigenous partners, on both a provincial and community level, to ensure that all families in British Columbia are provided with an equitable path towards success. As part of this commitment, the work being done to form this approach will build on actions, legislations, and partnerships that are currently in place or underway.

Report released addressing social work oversight in BC.

A report on a 2022-2023 study regarding social work oversight in British Columbia has now been released (bit.ly/3XoEFmy). This study, led by MCFD, engages social workers, ministry partners, and public individuals on topics such as practice requirements, standards, ethics, recruitment and retention, inclusion, equity, anti-racism, and truth and reconciliation. The discussions that took place resulted in the emergence of the following three major themes:

- accountability for social workers to better protect public safety;
- addressing systemic barriers that inhibit access to supports and improving the overall registration process;
- and supporting the delivery of high-quality results that enhance the well-being of individuals, families, and communities.

Opinions on how to approach the oversight vary. While some participants believe in implementing an increase in the regulation of social workers, others express concerns about systemic issues that impact the current state of social work.

Following this report, MCFD will continue to work with Indigenous Peoples and partners to determine next steps and make necessary changes.

Agreements signed between Province and Sts'ailes Peoples, as well as between Province and Cowichan Tribes.

In June of this year, Chief Cindy Daniels (Sulsulxumaat), Cowichan Tribes; the Honourable Patty Hajdu, Minister of Indigenous Services, and the Honourable Grace Lore, Minister of Children and Family Development signed a historic agreement to protect the inherent rights of Cowichan Tribes to look after their families in alignment with their cultural beliefs and practices. The agreement supports the implementation of Snuw'uy'ulhust tu Quw'utsun Mustimuhw u' tu Shhw'a'luqw'a l' Smun'eem (The Laws of the Cowichan People for Families and Children).

In early September another agreement was signed by Siyam te Sts'ailes (Sts'ailes leadership); the Honourable Patty Hajdu, Minister of Indigenous Services; and the Honourable Grace Lore, Minister of Children and Family Development. This agreement confirms the implementation of Snowoyelh te Emi:melh te Sts'ailes, the Snowoyelh Department to oversee the safety and well-being of Sts'ailes children and families while maintaining strong connections to cultural identities, beliefs, and practices.

Apply for a Camps For Kids Grant Fall/Winter Cycle

The Camp For Kids grants were established by BC Foster Parents Association to alleviate some of the costs member foster caregivers encounter when sending their foster, adopted, or birth children to camp.

Amount of grant:

An annual grant of \$300 per family.

Who can apply:

- You are a current foster caregiver and BCFPA member who requires assistance to send their foster, adopted or birth children to camp.
- The child/youth attending camp must be between the ages of 6 and 18 years old.

Application requirements:

Proof of deposit or full payment for the camp that the child/ vouth is enrolled in.

When to apply:

Applications will be accepted from August 1 - October 31.

How to apply:

Complete an online application form at **bcfosterparents.ca/ form-camps-for-kids-grant-application/**. Don't forget to fill out all the information and include all required documentation at the time of application. Contact our staff at **1-800-663-9999** or **office@bcfosterparents.ca** if you need any assistance.

Next steps:

Once the application has been reviewed, Applicants can expect to be notified in November, regardless of application status. Cheques are issued payable to the applicant and sent to the applicant's mailing address. Please allow four weeks from the date that you receive the notification for your cheque to arrive.
